Failure to file application for renewal of permit not later than November 30th of each year will incur penalties, to include 25% of permit fee plus 6% interest per annum until paid, and if sued on, or placed in the hands of an attorney for collection, the delinquent owing for such permit shall pay attorney's fees plus 10% penalties and interest. All applications for City permits shall be sent to the City Clerk, City of Minden, Post Office Box 580 Minden, Louisiana 71058.
